General Business Meeting Minutes

Call to Order

President Marian Aguillard called the meeting to order at 10:25a.m.

Nominations and Voting

Ed Flynn, Nominations Chair, presented the nominations assisted by Sharon Parker. Steve Aguillard was nominated for Vice-President, Robert Freeman for President-Elect, James Miller for Treasurer, and Jodi Miller for Secretary. Nominations were requested from the floor three times. No other nominations were heard. The nominations were accepted as noted above, and approved by acclamation.

Ed then presented nominations for 5 Board seats and 2 alternates and additional nominations were then requested from the floor. Close of nominations for these positions were noticed three times by Ed Flynn, a motion by Marty Guidry moved to accept the nominations and it was seconded by Steve Aguillard. The motion carried.

After voting took place, and while the totals were being counted, Marian convened the business meeting.

Treasurer's Report - James Miller

James Miller read the Treasurer's report. Available funds to date are currently \$4,867.29. This total does not include finalization of conference expenses and income. The current scholarship fund equity is \$34,784.7. The dues notice will go out after the conference. All conference participants have received complimentary membership.

Secretary's Report – Jodi Miller

The following are achievements/ happenings of the year 2003 to the present.

State Science Fair Projects were judged by LEHA for the first time in 2003. Three awards were presented to the 1st, 2nd, and 3rd place winners of the High School level and Junior High level that best exemplified the Environmental Health area. The prizes of \$50 and a plaque were awarded to the first place winner; and \$25 and a plaque were awarded to the second and third place winners. Thanks to Joan Adams for the idea. Also, thanks to Joan and Betty Vidrine for volunteering to judge this first year.

Three College Scholarships of \$1000 each and a plaque were presented in 2004 to:

A LEHA representative, Henry Graham/Pete Romanowsky served on the **Steering Committee of the Governor's Louisiana Environmental Leadership Program.**

The 2003 Conference Photo Album was posted on the LEHA website, LEHA.net .The Lafayette Conference was very successful, with a pre-conference workshop on Bio-Terrorism with emphasis on Louisiana Preparedness. We also had a special behind the scenes tour of the McIlhenny pepper sauce factory as our conference field trip.

Yesterday, we had a terrific conference on Wastewater Treatment and Bio-solids Treatment, Technology, and Beneficial Reuse. The field trip was to the Bonnet Carre' Spillway, including an in-depth presentation on the history and operation of the facility.
