

# Louisiana Environmental Health Association General Business Meeting Minutes Best Western on the Lake, St. Francisville, LA January 26, 2005 10:15 am

# Call to Order

President Walter Pichon called the meeting to order at 10:20 a.m.

# **Nominations and Voting**

Walter Pichon, Nominations Chair, presented the nominations to the General Membership, assisted by Marian Aguillard. Steve Aguillard was nominated for Vice-President, James Miller for President-Elect, Chris Mayeux for Treasurer, and Jodi Miller for Secretary. Nominations were requested from the floor three times. No other nominations were heard. The nominations were accepted as noted above, and approved by acclamation.

Walter then presented nominations for 4 vacated Board seats and 2 alternates and additional nominations were then requested from the floor. These were: Sharon Parker, Holly Herrmann, Judy McCleary, Melissa Murphy, Marian Aguillard (withdrew), Terry Bonnette, and Bill Schramm. Close of nominations for these positions were noticed three times by Walter. Marian Aguillard motioned to accept the nominations and it was seconded by James Miller. The motion carried.

After voting took place, and while the totals were being counted, Walter reconvened the business meeting.

#### **By-laws Changes**

The following By-laws changes were presented with discussion:

Amendment to Article XII of the Constitution involved the number of votes required to approve an amendment; this change was designed to correspond to procedures in Robert's Rules of Order.

The amendment to Article III of the Bylaws included switching Sections 1 and 2 so that the President was listed first. Other changes to these sections reflect current practices with regard to representation on the NEHA Council of Delegates.

Revisions to Article V, Section 1 of the Bylaws will allow more time for the Constitution and Bylaws committee to submit proposed amendments to the Secretary.

The by-laws changes were passed by the General membership.
