PRESIDENT'S MESSAGE

Do Environmental Health Concerns Matter to People?

Should environmental health concerns matter to people? Should the public take notice or care about what environmental professionals do? Does environmental health affect people in meaningful ways? The answers to all three questions, I believe, are yes.

Public health concerns and their related environmental factors are on the minds of many people in south Louisiana these days. The state has battled a serious outbreak of West Nile virus (WNV) over the past several months; terrorism (whether biological or chemical) remains a national concern following the tragic events of September 11th 2001; and with hurricane season upon us, there are additional concerns in many Louisiana communities about flooding and flood waters. Tropical storms and hurricanes both can cause these and other type problems; exposures to waters that may be contaminated with raw sewage or septic tank backup can lead to a whole host of bacterial gastrointestinal diseases.

In fact, in the immediate aftermath of flooding conditions created in south Louisiana by Tropical Storm Isidore last month, DHH ordered a precautionary closure of all oyster harvest areas located from the Louisiana-Mississippi state line to the Atchafalaya River. This public health action was based on the state health officer's fundamental concern that Isidore might have caused natural contaminates to be washed into rivers, bayous and streams where they could then easily flow into oyster growing areas. The temporary closure allowed for water testing that could assure oyster harvesters and the oyster-eating public that only fresh, clean oysters were being harvested. DHH used its authority under LSA-R.S.40:5,3 to take this action and close these waters.

Another current example of environmental health and public actions is WNV. This mosquito-borne disease can cause encephalitis (a brain infection). As most people know, mosquitoes acquire the virus from birds and can pass it on to other birds, animals, and people. In Louisiana, as elsewhere, the majority of people who get infected with the virus have no serious illness. However, older people do have a higher risk of becoming ill simply because as people get older, they have a more difficult time fighting off disease.

In fact, at least 11 people in Louisiana have died from WNV this year. Environmental health professionals (many of who are LEHA members) are employed in the Office of Public Health (OPH) where they support an aggressive infectious disease epidemiology program. LEHA members and other environmental health professionals are on the front lines working to reduce or eliminate this disease and help the public better protect themselves from this and other viruses.

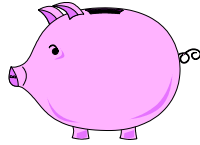
At DEQ, home to many LEHA members, Secretary Dale Givens, a LEHA friend and supporter, has recently retired and been succeeded by L. Hol Bohlinger, a 31-year state employee. Dr. Bohlinger has a strong environmental health background with an undergraduate degree from Southeastern University and a masters and Doctor of Science in environmental science (nuclear specialty) from Tulane University. On behalf of the Board of Directors, I offer LEHA's congratulations to Dr. Bohlinger on this appointment. Even a change in Secretary however, doesn't stop the important environmental work done at the Department. Water quality management plans are moving ahead; in air quality, revisions to the state implementation plan (SIP) are being proposed; and many other important matters are progressing as well : underground storage tanks (UST); radiation protection measures; lead-based paint; standards for sewage sludge; procedures for inactive or uncontrolled sites to name just a few.

I hope you agree with me: environmental health matters do matter! They are important and they affect us in our day-to-day lives. Topics such as the ones I've mentioned here will be on the agenda for our upcoming annual education conference in January 2003 in Lafayette. Our Professional Development Committee, chaired by board member Walter Pichon, has been hard at work organizing the conference. 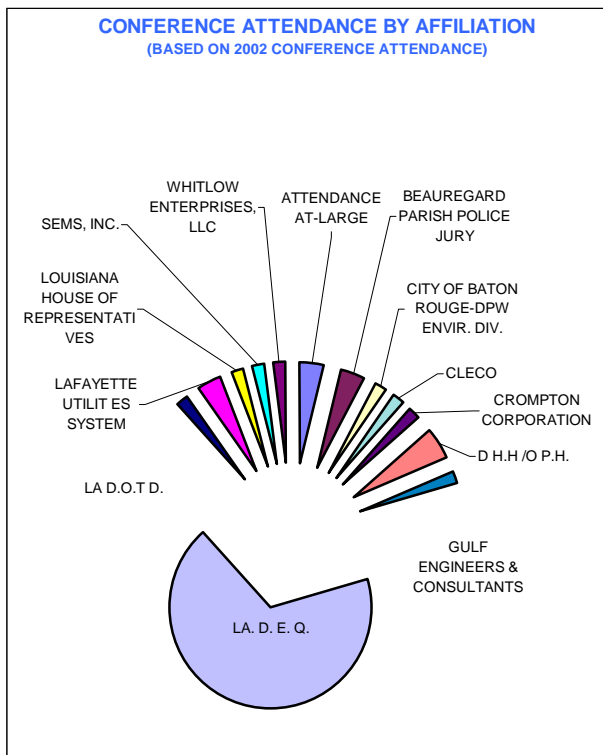
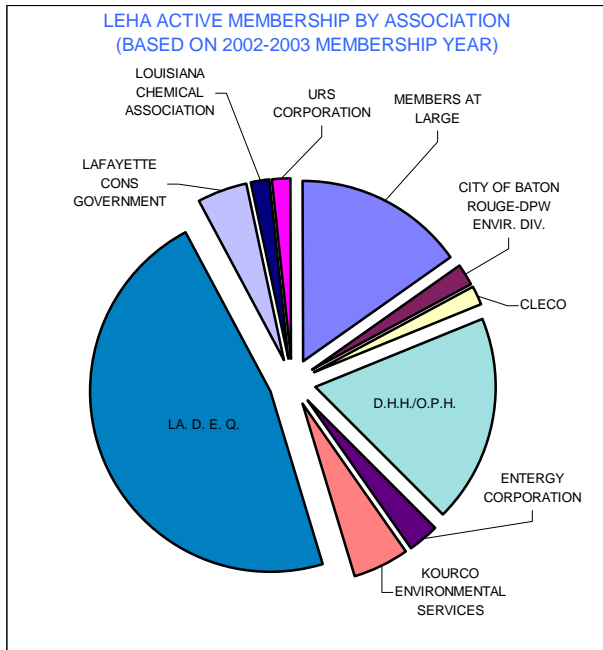
