I mentioned to Jim later that they might consider looking at disciplinary policies already in place for other professions like engineers, doctors, lawyers, etc.


By the way, the LEHA website (www.LEHA.net) is great and filled with current information for environmental health professionals in Louisiana.

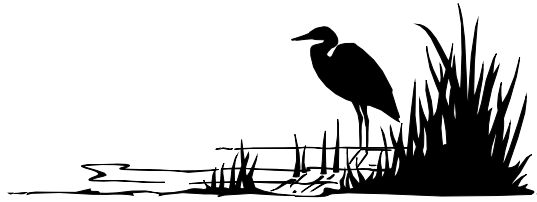
